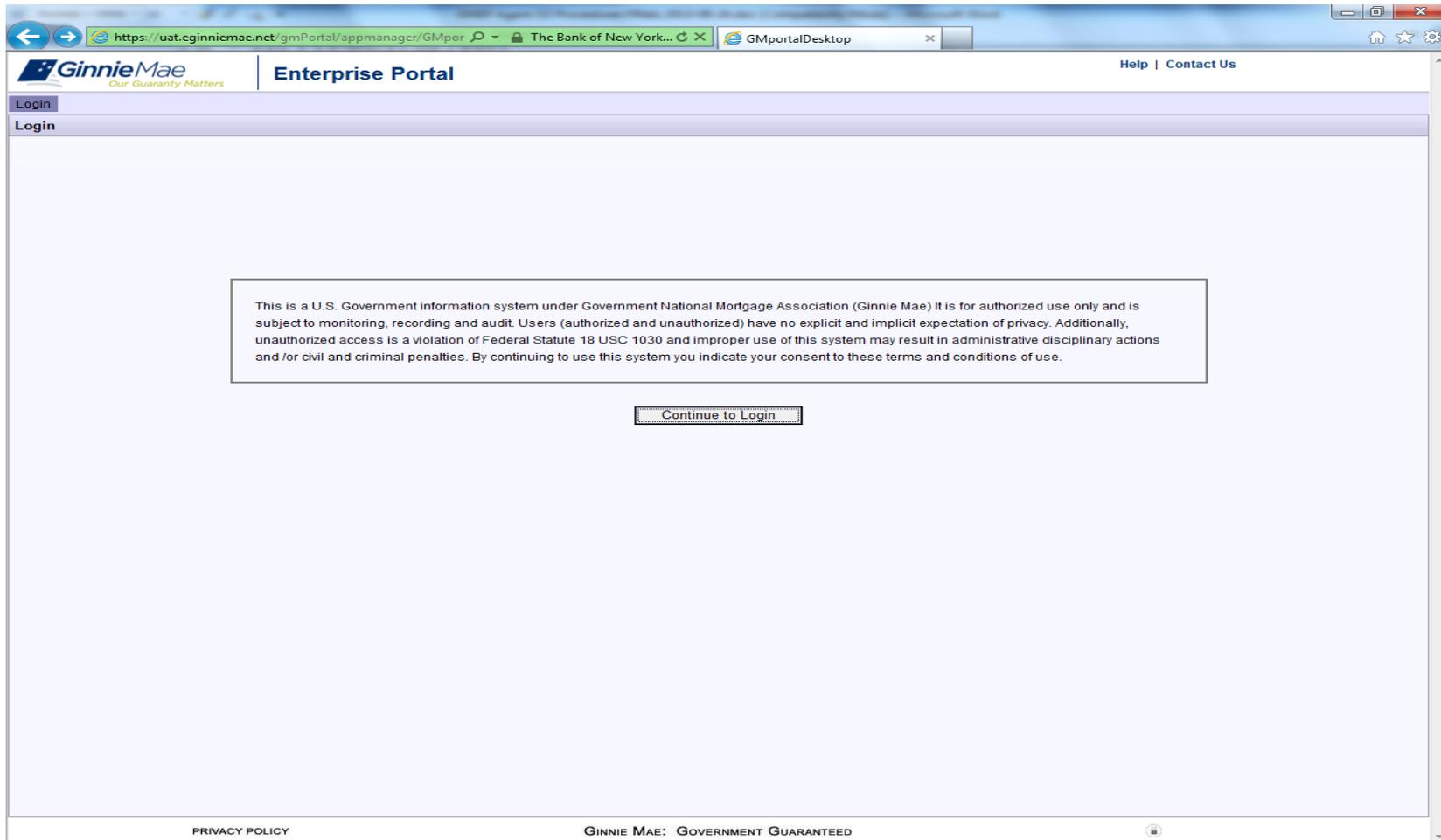

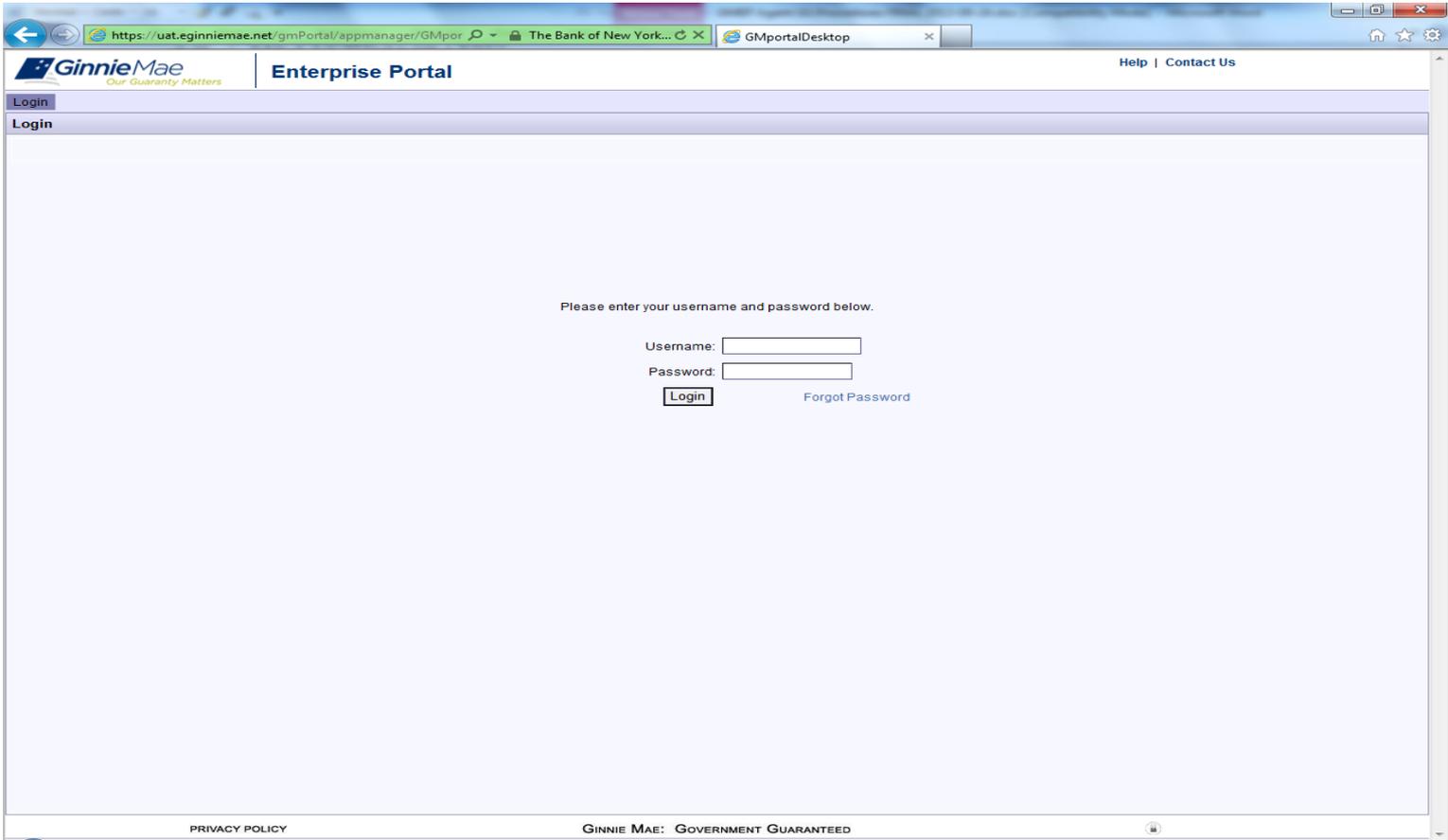
- New functionality for Requesting Pool Numbers , Commitment Management, and submission of Master Agreements will be effective December 16th, 2013.

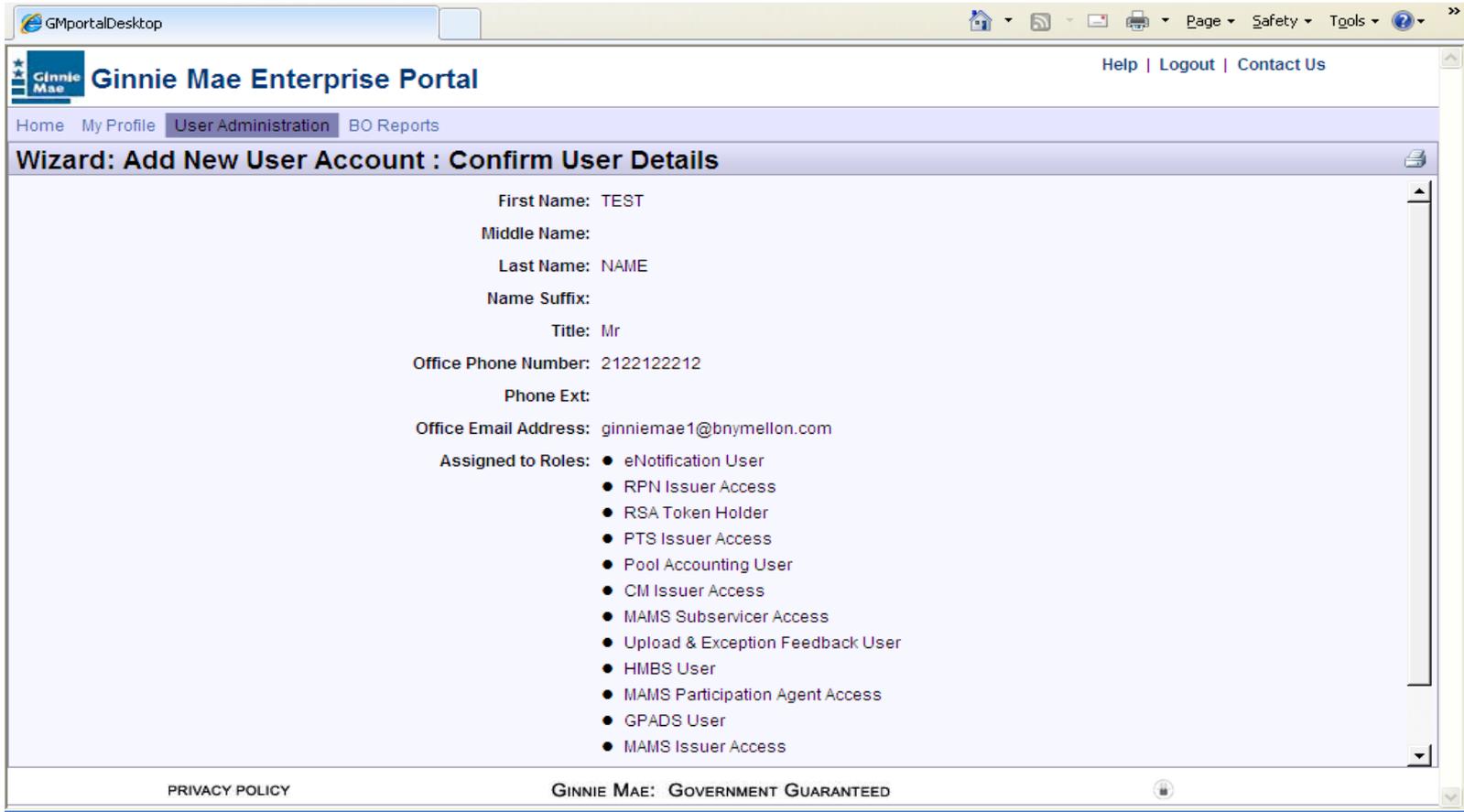
